SUMMARY ANNUAL REPORT FOR

STATIONARY ENGINEERS LOCAL 39 ANNUITY TRUST FUND

This is a summary of the annual report for Stationary Engineers Local 39 Annuity Trust Fund, EIN 94-2782214 for the year ended December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$12,146,795. These expenses included \$429,056 in administrative expenses, and \$11,717,739 in benefits paid to participants and beneficiaries. A total of 6,842 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$248,835,029 as of December 31, 2022, compared to \$288,055,834 as of January 1, 2022. During the plan year the plan experienced a decrease in its net assets of \$39,220,805. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of (\$27,074,010), including employer contributions of \$11,555,918 and earnings from investments of (\$38,629,928).

Minimum Funding Standards

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.

4. Insurance information including sales commissions paid by insurance carriers; and
5. Information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
